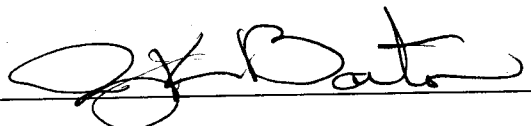

## **ADJOURNMENT**

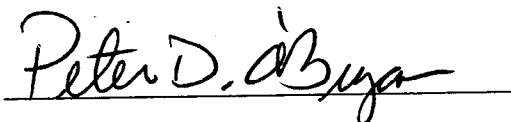
There being no further business, the Chairman declared the meeting adjourned at 11:30 p.m.
